

# Divine Birth - "Jesus Centre Goa". Alfran Plaza, Panaji, Goa.

On 1st March 1993, the property on which Alfran Plaza is presently situated was given for development, to M/s Alfran Construction Company Pvt. Ltd. based in Mapusa. I was the Advocate for M/s Alfran Construction Company at the time of this project. The foundation stone for the construction of Alfran Plaza was laid in 1994. The work of construction continued up to 1996, and in early 1997 when 80% of the structure of the building was completed, the booming real estate business in Goa came crashing down and due to lack of finance with Alfran Company, the construction work at Alfran Plaza, came to a complete standstill. It remained thus, for nearly 7 years, up to November, 2003.

In the beginning of 2003, while it remained incomplete I came to know that, Alfran Company was trying to sell the incomplete project to the very agent of the person who had filed a false case against some of the owners of this property, as the property was not given to that particular Builder, by the owners. Moreover, I along with Alfran Company at the time of signing the development agreement had given specific assurance to the said owners that Alfran Company themselves will complete this project. Under these circumstances I requested the M. D. of Alfran Company, Mr. Carlos Mauricio Fernandes not to enter into the said deal with that particular person. Although he agreed with me, I felt he was ready to give it to any person to complete it, as he was under tremendous pressure from the purchasers of the units to complete Alfran Plaza.

I prayed to the Lord at Bambolim Church, where I used to go to pray before the Blessed Sacrament, that the above deal may never be materialised as it was going against our assurance given to the owners of the property. Right enough after some months the Lord answered my prayers and I came to know that, the deal did not work out. After this, I began to pray to the Lord to send another person who would complete this building, if it was His will; because I was mainly responsible to convince the owners to give this prime property to Alfran Company for development in 1993, despite of strong competition to purchase the same by the other builders, and hence I was morally responsible to see that, the project was completed by Alfran Company.

After waiting and praying to the Lord for almost six months, the Lord, answered my prayer and He used me, as His instrument to complete the Alfran Plaza building, inspiring me to establish "Jesus Centre", in order to glorify Him from there. This is how it happened.

One day, Fr. Eufemiano Miranda, nephew and P. O. A. of the owners, had come to notarize some documents in my office At that time he asked from me whether Mr. Mauricio was doing anything to complete Alfran Plaza or would keep it incomplete forever. After Fr. Miranda left, a little while later, Mr. Noel Fernandes, the nephew of M. D. Mr. Mauricio Fernandes, came and told me, he had gone to HDFC Bank to ask for a loan, to complete Alfran Plaza, but the bank refused. That very moment as I was speaking to him, the Spirit guided me to meet Mr. Sanjay Koppikar, whom I knew earlier, the then manager of G. I. C. Housing; The Spirit also indicated Mr. Sanjay would do the needful, but when I met him he informed me GIC gives loan only for housing and not for commercial projects, but he immediately added, that he has a person who could complete Alfran Plaza building, as he has completed unfinished projects of other builders in Porvorim. I told Mr. Sanjay to confirm with him and let me know, and if he was willing to complete Alfran Plaza, I would meet him later.

Later, Mr. Sanjay informed me that the said person Mr. Venkatesh N. Prabhu Moni was willing to meet us to discuss the proposal of completing Alfran Plaza. Mr. Mauricio Fernandes along with Mr. Noel Fernandes, and I met Mr. Prabhu in Mr. Sanjay's office. After much discussion, we gave him a proposal to give him a half constructed project at Mapusa [Mount Mary's] and  $1/3^{rd}$  of the total built up area available at Alfran Plaza which was around 2000 sq. mts. in order to complete it. He said he will study the proposal and let us know within a few days.

Mr. Prabhu informed Mr. Noel, that he was willing to accept the said proposal, provided he was given the remaining entire built up area of 2000 sq. mts. at Alfran Plaza, in addition to Mount Mary's project at Mapusa. When Mr. Noel informed me about it, I prayed to the Lord and the Spirit guided Me, to take over the negotiations alone on behalf of Alfran Company, to settle this matter with Mr. Prabhu. After obtaining consent from Mr. Mauricio, I began negotiations with Mr. Prabhu.

Then the Spirit guided me to tell to Mr. Prabhu that, Alfran Company could give him only 1500 sq. Mts. built up area at Alfran Plaza, out of 2000 sq. Mts. unsold built up area available and that 500 sq. mts. balance built up area, was needed by Alfran Company to pay the compensation to the owners for the delay, as per the provisions of original agreement dated 01<sup>st</sup> March, 1993. I told Mr. Prabhu that only 1500 sq. mts. could be given to him and the remaining 500 sq. mts. of built up area would be required to settle the compensation, for the owners.

In the meanwhile, the Spirit began to indicate to me that, Mr. Prabhu would accept the proposal, although Mr. Mauricio Fernandes was becoming increasingly

impatient, in the fear of losing Mr. Prabhu and was ready to give in to his demand, but as per the guidance of the Spirit, I stayed firm. Right enough, after several months of negotiations, Mr. Prabhu agreed to complete Alfran Plaza with 1500 sq. mts. built up area being given to him at Alfran Plaza, along with Mount Mary's project at Mapusa.

In the meanwhile several rumours were spread in the market about Alfran Plaza by the interested parties, which came in the ears of Mr. Prabhu, and many a times, he almost withdrew from the deal. But on those occasions, the Spirit indicated that, he would sign the deal because "God Himself wanted to place him there, to complete Alfran Plaza which would be used for His glory". Therefore every time he hesitated, I reassured him that everything would be fine, and that he should not worry about rumours which were false. On the basis of my personal assurance, Mr. Prabhu agreed to sign the agreement. Thus, on 28th November 2003, an agreement was signed between M/s Alfran Construction Co. Pvt. Ltd. and M/s Prabhu Constructions, to complete the Alfran Plaza and the work of re-completion commenced on 1sth December 2003, and was scheduled to be ready, within a period of one and half year, from the date of signing of the said agreement.

On account of the delay in completing the project some of the owners had filed a suit for compensation against Alfran Company. When I was praying to the Lord about it, the Spirit indicated the matter would be finally settled amicably. I informed Mr. Mauricio about the same. The suit for compensation for delay was dismissed by the court on 29<sup>th</sup> April, 2004. When this happened, the said co-owners wanted to file an appeal in the High court against the judgement of the Lower court. Again at this juncture, the Spirit guided me, to offer a compromise to both the parties, standing as a mediator between them, as relations between them were strained on account of filing of the said suit.

As per the guidance of the Spirit I convinced the Directors of Alfran Company, to offer a compromise to the owners, although the suit was dismissed, because if the appeal gets admitted in the High Court, the whole project would be stalled for several years, and as a result Mr. Prabhu would also seek compensation for delay, as in the meanwhile he had already invested a lot money for the completion of Alfran Plaza. So I prepared an addendum to the original agreement (compromise terms) and offered to pay an X amount as a compensation for delay in the form of built up areas to the owners and gave it to Fr. Miranda to pass it on to his uncle Lamarck Clement through his advocate. The Spirit confirmed that the matter will be settled amicably without going to High Court.

"I have washed you, cleansed you of your past sins, as you have already turned away from them. I have already forgotten about them. I have thrown them into the sea and I will remember them no more. Do not feel guilty about the past anymore."

"I have chosen you like my servant David, to be the shepherd of my people. I will make use of all your talents which I have given you, to proclaim the Good News to the people of God". "Like Prophet Jeremiah I have chosen you before I gave you life". "I have selected you to be my mighty vessel to all the people. Don't be afraid of them, because I will be with you to protect you". (Jeremiah 1:8)

Then came the initiation of Jesus Centre at Alfran Plaza on 6th April, 2004.

"You do not worry, go ahead with my work. Establish Counselling – cum – Media cum Prayer Centre at Alfran Plaza. Everything needed, will be provided by me for that Centre and I will guide you how to set it up."

"I will give you all the monetary help that is required to set up the Centre. Besides the hall, it will consist of Counselling Centre and Media Centre, for the evangelization program of my kingdom. Don't worry; I will give you the required personnel to work there. This is my confirmation regarding the Centre at Alfran Plaza".

The Divine Providence guided the events so as to facilitate the possession of premises at Alfran Plaza to establish Jesus Centre. In the beginning of this revelation, I did not comprehend, how I would establish a spiritual centre in a commercial building but soon enough, the Spirit began to further indicate that, out of that 500 sq. mts. built up area that remained in balance and unsold, which was not given to Prabhu Construtions, the Lord would make it possible to settle the said co-owners demands for compensation with a part of that built up area, while the remaining built up area, God wanted for His purpose to use for His glory. The contiguous and adjacent area, that was unsold and suitable for this purpose, was available on the 2<sup>nd</sup> Floor of Alfran Plaza.

When I received this revelation, I called Alfran Company Directors, Mr. Carlos Mauricio Fernandes and his brother Mr. Paulito Fernandes, and told them that the said 500 sq. mts. built up area would be required by me, to solve the co-owners demand for compensation and the remaining built up area, **God was asking "for His purpose to use it for His glory"**. They agreed in principle, to give the said built up area of 500 sq. mts.,

for these two purposes. In fact, God made them agree willingly. On 07<sup>th</sup> April, 2004, the Spirit guided me to tell them, "not to regret for a moment, to give the indicated premises at Alfran Plaza, for setting up the said Centre to be used for His glory. On 5<sup>th</sup> June, 2004, the Spirit guided to name it Jesus Centre". I did not know what legal document to be prepared to acquire the premises for Jesus Centre. The spirit guided to prepare PERPETUAL LEASE AGREEMNT for 99 years with Alfran Company and myself and later when Jesus Centre Society is formed to transfer the same on Jesus Centre society. The Spirit also guided to obtain power of attorney in my name from both the directors of the Alfran Company for this purpose, which I did and later transferred the premises on Jesus Centre Society on 16<sup>th</sup> November 2006 on the formation of the society.

## 05th June, 2004

"Do not worry about the Centre, My Centre. It will be established at Alfran Plaza, and name it as "JESUS CENTRE".

"I will reveal to you how to set up Jesus Centre at Alfran Plaza and from whom you should take help. Now you sign the perpetual lease agreement, to acquire the premises from Alfran Company which you have prepared, thereafter I will guide you to do the rest".

Thereafter the Spirit further revealed that, the Spiritual Centre, will consist of a sound proof hall, large enough to accommodate people to conduct prayer meetings and retreats. There would be also a Media Centre, for selling books, printed materials, audio & video CDs, cassettes etc. for evangelization work of God's kingdom. The spirit further inspired and indicated that, "with your skill of management and the leadership qualities which I have given you, you will accomplish the task I set before you, do not falter for a second, but go ahead resolutely, and accomplish the task as soon as possible, and I will provide all that is needed, regarding the Centre at Alfran Plaza".

In the meanwhile, I encountered several problems that arose between the said co-owners and Alfran Company as regards to the compromise terms and compensation to be paid by Alfran Company to the said co-owners. On 03<sup>rd</sup> July, 2004, the Spirit revealed that, "All problems would be sorted out amicably and this would happen because, the Directors of Alfran Company, Mr. Mauricio Fernandes and Mr. Paulito Fernandes have agreed in principle, to give the space indicated to establish 'Jesus Centre' at Alfran Plaza, as desired by Him, in order to glorify Him and proclaim His kingdom." I was also guided to tell them to give the said premises with gladdened heart and willing mind, and never to hesitate, because Alfran Plaza was brought back to life by

God through me, in order that He may be glorified and proclaimed from there. The Spirit also guided me to tell them, not to have any doubts whatsoever about it, and they would see it with their own eyes.

The Spirit also indicated on 03<sup>rd</sup> July, 2004, that, the preparation for the work of proclamation and evangelization, in terms of human power, to work for His Kingdom at Jesus Centre, to be established, was already going on in Don Bosco Night High School Panaji, Goa, where in, I was the Principal of secondary and higher secondary school at that time. At that time I was teaching the Bible and conducting prayer meetings in the night school.

## July 2004

"Nothing can stop Alfran Plaza from being completed; it is under my mighty power and care. Don't worry, so also the preparation for the work of evangelization at My Centre at Alfran Plaza is going on in the night school. Then you will shift over there from the school. Don't be afraid to take a decision as I direct you".

In the meanwhile, the problems between the said co-owners and Alfran Company became almost insurmountable, as the said co-owners refused to accept the built up areas that we offered to them, in lieu of compensation, and demanded much higher compensation than what we offered. They also demanded that the amount be paid in demand draft in one instalment. At that time Alfran Company did not have any money to pay them. I prayed to the Lord continuously for a solution to this problem, and when a compromise seemed almost impossible, on account of lack of finance, on 15<sup>th</sup> July, 2004, the Spirit inspired and said: "I will use My mighty power, to solve all the problems at Alfran Plaza, and get you there to do my work in the Centre".

## July 2004

"Many trials and tribulations, persecutions will come upon you and you will feel like giving it up, but be firm and steady for I am with you. The cost of following Me is very heavy and difficult, but My power and grace is sufficient for you".

After much bargaining by me, on 20<sup>th</sup> July, 2004, the lawyer of the said co-owners informed me that, the signing of the compromise terms, [addendum] may be possible, if Alfran Company pays at least half of the agreed amount at the time of signing of the compromise terms, failing which he has been instructed by his clients, to proceed to file an appeal in the High Court within the limitation period. The agreed compensation amount for delay was exactly around the market value of about 220 sq. mts. of the said built up area at that time.

Alfran Company did not have a pie in the pocket, to pay the said co-owners, but the Spirit continued to guide and the Lord gave this comforting message on 21<sup>st</sup> July, 2004. "See the Lord's hand is not too short to save, nor his ears are too dull to hear" (Isaiah 59:1). "Do not fear for I am with you. Do not be afraid, for I am your God, I will strengthen you, I will help you I will uphold you with My victorious right hand." (Isaiah 41:10). The Spirit continued to guide me, not to panic and worry, because all these problems, both financial and legal that were being encountered would soon be solved, and everything would fall in into place beautifully and Alfran Plaza would be used, to proclaim His glory and Jesus Centre would be established there.

The Spirit then guided me, to ask the required amount, from Mr. Prabhu to sign the compromise terms, through Nielsen Braganza his manager. So I called Mr. Nielsen and explained to him, the need to have the required amount, in order to sign the compromise terms to put an end to the dispute, between Alfran Company and the said co-owners. Also in the meanwhile and about the same time Mr. Prabhu's lawyers, demanded from him, a P.O.A. and confirmation of his agreement with Alfran Company by the owners of the property in order to give him a clear title, to sell the built up areas allotted to him under the said agreement. In fact, God, Himself created these circumstances for Mr. Prabhu so that he may agree to give the required amount, as he did not have the option of withdrawing, because by this time, he had already invested a lot of money for the completion of Alfran Plaza. Due to these circumstances, which God truly created, Mr. Prabhu agreed to buy two incomplete shops, on the first floor of Alfran Plaza and give the required amount to Alfran Company, to pay to the said co-owners in order to sign the compromise terms.

After much trials and tribulations, both financial and legal, which seemed impossible to solve with human power, true to the guidance of the Spirit and foretold knowledge, the Lord provided the necessary finance through Mr. Prabhu on 06<sup>th</sup> August, 2004. On 10<sup>th</sup> August, 2004 and 12<sup>th</sup> August, 2004 [Compromise terms] addendums to agreement dated 01<sup>st</sup> March, 1993 were signed, between the owners of the property and Alfran Company, putting an end to litigation and dispute, which lasted more than five years and so also the Perpetual Lease Agreement acquiring the premises to set up Jesus Centre at Alfran Plaza was signed on 10<sup>th</sup> August, 2004. On 20<sup>th</sup> August, 2004, the Spirit indicated that, "Although Alfran Plaza was built for the rich and the mighty of this world, it will now be used for His glory and the proclamation of His Kingdom. The hall of the Centre will be used for the purpose of evangelization work".

On 10<sup>th</sup> February, 2005 The Spirit indicated that Jesus Centre has been assigned a threefold mission:

- To bring the unbelieving brethren into His Light, Hope and Resurrection. Jesus Centre has been given the distinct mission of bringing unbelieving souls into His Kingdom.
- To save the youth from the deadly scourge and snares of the enemy and set them free from drugs, sexual immorality, fornication, drinking, smoking, gambling etc. and bring them back to God.
- iii. To protect the institution of the family from breaking-up, and to save broken families in love of God and unite them together. Jesus Centre has been chosen to seek and collect the lost sheep and set them free in His name.

### February 2005

"You have been chosen to seek and collect the lost sheep and set them free in My name. Jesus Centre will be used for the proclamation of My kingdom and glorify Me alone".

### March 2005

"Jesus Centre is coming into existence in a mighty way to set the captives and the broken hearted free from the prison of sadness, sickness, pain and fear".

## May 2005

"My son I have chosen you for my unique work of proclaiming the Gospel to My unbelieving children. This is the most important work of My kingdom. Wait patiently for my time. My time is best time; there is no other best time".

# August 2005

"My centre comes up in Panjim, and through My centre everything will be set ablaze for My kingdom in Panjim, Goa and ends of the earth. My son I have chosen you to destroy the kingdom of the devil and re-build my kingdom of righteousness, peace and joy of the Holy Spirit. My son you will face trials and tribulations but victory will be yours because I am with you always".

## August 2005

"My son, My centre will vibrate with my spirit and I will pour love from heaven at my centre to set free the captives from the snares of the enemy. I will perform mighty signs wonders and miracles. I will open their eyes to know I am the only GOD of Heaven and Earth and there is no other GOD before Me".

The Spirit also indicated that "a new door had been opened in front of me at Jesus Centre, no one could close or shut it off" (Revelation 3:8), and it would vibrate with His love, power and Holy Spirit, and set free the chains from the people, who come there of the evil one! "The kingdom of the devil will be attacked and destroyed at Jesus Centre, where the devil will be stripped in true colour and form, and exposed in his 'ugly face'. In order to destroy the kingdom of the devil, Jesus Centre will be anointed with the mighty power of the Holy Spirit, and it is the Holy Spirit which is bringing people back to the Church, His Bride. The plan for Jesus centre will be a plan for great renewal and rejoicing of the Church."

The Spirit also revealed that, Jesus Centre would become the joy of living, because it would vibrate with His mighty Holy Spirit, pouring love from heaven, setting captives free from fear and bondages, pain and sadness, deliver the sick and the disabled, the broken hearted, from the deadly scourges of the evil one. The Spirit further indicated to keep the "Jesus Centre Hall" immaculately clean just like His mother so that the mighty power of the Holy Spirit would live and fill the place to set free the captives from the snares of the enemy.

The Spirit further indicated that, Jesus Centre was truly going to be a mighty renewal Centre in the heart of Panaji bringing to Him, His unbelieving children. I was further directed to remain steadfast and not to compromise on His teachings. "Preach fearlessly like John the Baptist and prophet Jeremiah, without fear because My people must understand My word clearly, and devil must not able to twist My Word and cheat them".

Jesus Centre was blessed and inaugurated on 16<sup>th</sup> April 2006, by late Fr. Antimo Gomes, the then Parish Priest of Mary Immaculate Conception Church, Panjim, as per the guidance and direction of the Spirit to bless it on Easter Sunday of that year, even before Alfran Plaza was fully completed and ready for occupation. In fact it was much later that I was elected as Chief Promoter and helped to bring the building to order. Thereafter I formed the Alfran Owners Maintenance Society in 2008 and I was elected as the first Chairman of the society. It is because of Jesus centre that I went through the trouble and suffering to form a society to manage the building. The said society is managing Alfran Plaza now. I would like to thank the Managing Committee of the Society for their co-operation and support to the mission of Jesus Centre.

## April 2006

"Go ahead with all preparations for the blessing of the centre on the 16<sup>th</sup> April, 2006 a special day, the day my Father shone His glory all over the world by giving me new and everlasting life and to everyone who obeys and believes in me".

"My son, My church will participate in my centre mightily with their support

and participation. Do not worry I have ordained it".

## January 2007

"My plan for you and My centre, a plan for great renewal and rejoicing of the church. My church will support you wholeheartedly you need not fear. I will unfold my plan to you, with regard to My centre, My glorious and loving plan, to build my church and my body in GOA and elsewhere. Be glad and rejoice I have chosen you for this unique work of rebuilding My church".

On 16<sup>th</sup> December, 2013, Jesus Centre Association has been formed in accordance with the Second Vatican Council's teaching and the code of Canon Law 1983, Christ's faithful as part of the people of God have the right to establish and direct association for the purpose of promoting their spiritual growth, serve charitable or pious purposes and foster the Christian vocation in the world. The Association has been formed as guided by the spirit in order to have ecclesiastical status under the Catholic Church as envisaged. "Can. 215, 298 §. 1 CIC'83". It is a lay organisation working in collaboration and obedience to the Church. The Lord Jesus Christ as a cornerstone is dedicated to proclaiming the Gospel of the Kingdom to the whole world. In this mission who are called, not by their merits, but by the grace of Almighty, for His work on Earth, will endeavour to strive towards the vision that "The Gospel of the Kingdom shall be preached all over the world, for a witness unto all nations". (Matthew 24:14).

The following messages have been received from the Lord through the promptings of the Holy Spirit with regard to Jesus Centre.

## November 2004

"My centre at Alfran Plaza will burn like fire in the midst of darkness; I will lead you, to green pastures of which you know nothing about. My centre will shine in Panjim like a light in the sky. You have been chosen to make the light shine in the sky".

### December 2004

"Jesus Centre will be a sacred place where people will change the direction of their lives by hearing My word and filled with My love and come back to Me".

## January 2007

"My centre established in My name will bring back my lost sheep to me and also the unbelieving ones, I have ordained it to happen. Thousands of unbelievers will come to worship and bow to Me the only living GOD of Heaven and Earth and will become My children through My centre."

## February 2007

"My centre will be a centre of renewal for My people and the Church, a great

awakening is going to bring to My people through My centre which My Father has opened in My name and it will accomplish the task for which it has been established".

#### June 2007

"My centre is a unique centre in Goa to renew My church, to make it vibrant and alive through My word. I will send you to My churches to give my life giving word to my people".

### December 2007

"The power of resurrection will be displayed and shown to all in My centre. The blind will see, the deaf will hear, the lame will walk, and the dumb will speak, sick healed and those who are possessed by the devil will be delivered and set free and all the people will glorify Me and My Father".

### December 2008

"My son, I am preparing a way for you to be a lay leader in My beloved church, to build it and make it strong and vibrant in Goa. You will be given the task to help rebuild my beloved church in Goa and lead it to My pristine glory. My church will fully support you and My mission, for they will see with their eyes the works I will do through you. My son, the mission and works I have assigned and entrusted to you are beyond the understanding of ordinary people".

## July 2010

"My son, wait in patience for the time and hour to come, which is known only to my Father. The appointed hour will arrive as set by Him for His purpose and for proclamation of His glory. No one can take it away from you; it is already given to you by My Father. So my son, rest in joy and peace in My bosom till My Father shines His glory on you. Remain steadfast trusting me alone and depending on Me to give you victory in everything you do for My Kingdom sake".

## November 2010

"My son, out of the blue, I will lift you and My Centre to a glorious position and all your sadness will turn into joy as it happened to My disciples when I rose from death to life after My resurrection on the third day."

# 11th May, 2015

"My son everything is given to you through the 'ordeal of waiting' to make you strong and powerful in faith in Me. I want to lift you and your ministry and My centre to an extra ordinary position in the Archdiocese of GOA and therefore you have been kept waiting to make you more formidable against the enemy and powerful in Me. Longer the wait, more the power that will come to you. Just wait in full hope and trust to turn everything beautiful at My Centre and make everything new at Jesus Centre, just as it happened when I rose from dead and appeared to My Apostles; rejoice,

#### May 2015

"My son waiting is the true test, specially waiting through suffering and pain, my son your waiting and suffering time will now come to an end, a great rejoicing will begin, I the Lord have spoken through your mouth. I love you."

### May 2015

"My son I have trained you by the way of the cross, the way I followed which leads to heaven, to My Fathers kingdom. 
